SUMMARY OF PROCEEDINGS OF 27TH ANNUAL GENERAL MEETING HELD ON WEDNESDAY, THE 27TH SEPTEMBER, 2023 AT 4.00 P.M.

The 27th Annual General Meeting of the Members of the Company was held on 27th September, 2023 at 4.00 p.m. through two-way Video Conferencing (VC) / Other Audio-Visual Means (OAVM). The Meeting was conducted in accordance with the circulars issued by the Ministry of Corporate Affairs ('MCA') and the Securities and Exchange Board of India ('SEBI').

Shri Surendra Kumar Agarwal, Chairman of the Company, chaired the proceedings of the Meeting. The Chairman welcomed the Shareholders to the Meeting and on requisite quorum being present, called the Meeting to order.

All the Directors of the Company were present at the Meeting through VC from their respective locations. The Chairman introduced the Directors, Management Committee Members and the invitees present at the meeting.

The Chairman thereafter informed the Members that Shri Anand Gupta, representative of Anand Gupta & Associates, Chartered Accountants, Statutory Auditors and Smt. Kanchan Yadav of K Y & Associates, Company Secretary, Secretarial Auditors of the Company and Scrutinizers for the remote e-voting and the e-voting during the proceedings of the AGM, were also present at the Meeting through VC.

The Chairman informed the Members that the Report of Board of Directors, the Accounts for the financial year ended 31st March, 2023 and the Notice convening the 27th AGM were taken as read as the same had already been circulated to the Members. The Chairman read the qualified opinion of the Auditors in the Audit Report.

The Chairman informed the Members that pursuant to the provisions of the Companies Act, 2013, the Rules framed thereunder and the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Company had extended the remote e-voting facility to the Members of the Company in respect of the resolutions to be passed at the Meeting. The remote e-voting commenced at 9.00 a.m. on Sunday, 24th September, 2023 and ended at 5.00 p.m. on Tuesday, 26th September, 2023. The Chairman informed the Members that the facility for voting through e-voting system was made available during the Meeting for Members who had not cast their vote prior to the Meeting.

The Company had appointed Smt. Kanchan Yadav, Practicing Company Secretary, as the Scrutinizer for the purpose of scrutinizing the process of remote e-voting held prior and e-voting during the AGM.
